Notification of Department of Agriculture

Entitled: Determination of Details, Criteria and Procedure for Registration, Issuance and Extension of Hazardous Substances Registration Certificate under the Responsibility of Department of Agriculture (No. 4) B.E. 2554 (2011)

Subsequent to issuance of Notification of Department of Agriculture Entitled: Details of Criteria and Procedure for Registration, Issuance and Extension of Hazardous Substances Registration Certificate under the Responsibility of Department of Agriculture B.E. 2552 dated 14 October 2552 (2009), the criteria and procedure for registration of hazardous substance had been determined.

In order to enhance suitable and efficient hazardous substance registration, by virtue of the provision in No. 3, No. 5, No. 6, No.9, No.10, No. 14 (1) (2) and No. 15 of Notification of Ministry of Agriculture and Cooperatives Entitled Registration, Issuance and Extension of Hazardous Substance Registration Certificate Under Responsibility of Department of Agriculture B.E. 2551(2008) dated 1 December 2551, the Director-General of Department of Agriculture issued the following announcements.

- No. 1 To repeal the provision No. 6 (6) and (7) of Notification of Department of Agriculture Entitled: Details of Criteria and Procedure for Registration, Issuance and Extension of Hazardous Substances Registration Certificate under the Responsibility of Department of Agriculture B.E. 2552 and replaced by the following provision.
- "(6) If No. (3) (4) and (5) had been approved, the registrant or the agency assigned by the Department of Agriculture shall conduct efficacy trial under supervision of the Department of Agriculture.

The agency to conduct trial referred to in paragraph one shall have expertise relating to efficacy or residue trial of pesticide applied for registration.

(7) When the trial is finished, the registrant or the agency assigned by the Department of Agriculture shall submit efficacy or residue trial report together with the statement intended to put on the label, which had been approved under principle, procedure and conditions for experimental plan and report on efficacy trial of agricultural hazardous substance and the principle, procedure and conditions for residues trial of agricultural hazardous substance within 180 days commencing from the due date in experimental plan, at Hazardous Substance Regulatory Group, Office of Agricultural Regulation, Department of Agriculture.

The result of efficacy trial shall be valid no longer than 5 year commencing from the date of receiving the trial report from the concern agency.

The efficacy and residue trial result shall belong to the registrant only, it is not allowed to use by other person."

- No. 2 To repeal the provision No. 10 of the principle, procedure and conditions for experimental plan and report on efficacy trial of agricultural hazardous substance attached to the Notification of Department of Agriculture Entitled: Details of Criteria and Procedure for Registration, Issuance and Extension of Hazardous Substances Registration Certificate under the Responsibility of Department of Agriculture B.E. 2552 and replaced by the following provision.
- "No. 10 The Department of Agriculture assigns the following agencies to conduct efficacy trial.

- (1) Entomology and Zoology Association of Thailand
- (2) Plant Pathologist Association of Thailand
- (3) Weed Science Association of Thailand
- (4) Central Lab (Thailand) Company Limited"
- No. 3 To add the following provision to be No. 4 of Guideline on Principle, Procedure and Conditions for Residues Trial of Agricultural Hazardous Substance Annexed to Notification of Department of Agriculture entitled Details of Criteria and Procedure for Registration, Issuance and Extension of Hazardous Substances Registration Certificate under the Responsibility of Department of Agriculture B.E. 2552 (2009).
- "No. 4 The Department of Agriculture assigns the following agencies to conduct residue trial.
 - (1) Entomology and Zoology Association of Thailand
 - (2) Plant Pathologist Association of Thailand
 - (3) Weed Science Association of Thailand
 - (4) Central Lab (Thailand) Company Limited"
- No. 4 This Notification is effective one day after it is announced in the Government Gazette onward.
