PROJECT IMPLEMENTATION

The ePhyto system has been developed to be compliant with Appendix 1 of ISPM12. The system is compliant to Version 11.0 UN/CEFACT XML schemas for SPS Certificate and SPS Acknowledgement definitions (<http://www.unece.org/cefact/xmlschemas/index>). The XML format of the Department of Agriculture export certificate is defined by the SPS Certificate. The SPS Acknowledgement message is used for replaced and revoked certificates and as part of a SMTP conversation for acknowledging certificates or changing the status of a certificate.



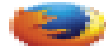

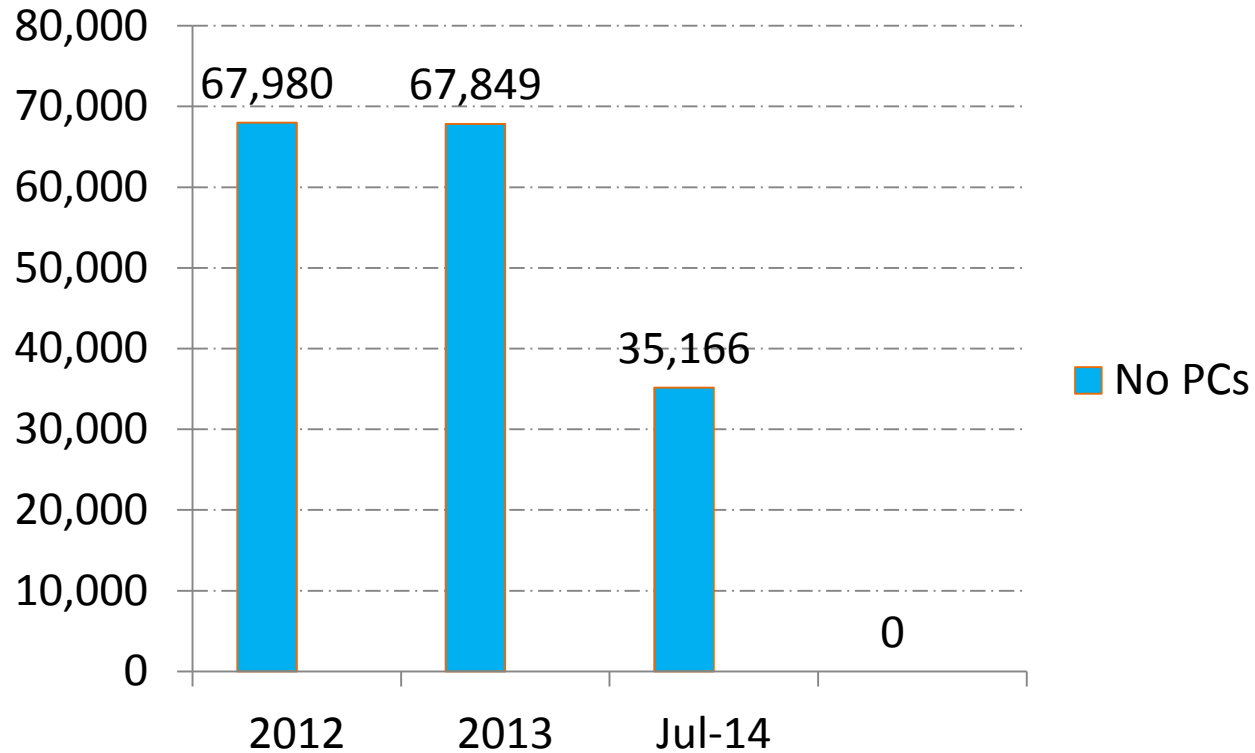
